Annual Membership Meeting 2023

The annual membership meeting of the Villas at the Ridges was held on May 24, 2023. A quorum of homeowners was met through attendance and proxy and business was conducted.

During the Presidents report, Ben McCartney reiterated that trash needs to be put in trash cans, not in bags on the street, and that it should not be put out any earlier than 7:00pm prior to the day of pick-up. He also discussed vandalism at the park and stressed if you see something, say something. Finally, Ben shared that the budget for 2023-2024 is complete and there will not be an increase in assessments this year. They will remain at \$195 per month.

An election for three seats on the Board of Directors was held and the eligible existing Board members were was reelected by acclimation. During the Board of Directors meeting directly following the Annual meeting all Board members were appointed to the same officer position in which they have been serving.

During the Board of Directors meeting after the Annual, the Board approved a contract to add landscaping to the area at the end of Lapis Court. Several other proposals were also approved. The Timber wall behind 303-311 Amber Circle will be removed and replaced and new plants will be added. The leaning sections of the block wall and fences in several areas in the community will be removed and replaced. Finally, the Board approved a contract to have all the fences in the community power washed.

Forms are available on the Villas at the Ridges page on the ARMI website at https://www.armi-hoa.com/villas-at-theridges-unit-owners-association or by contacting the ARMI office.

Send your completed form to the ARMI processor at <u>HoaAssistant@armiva.com</u>. You should include a plat showing the location and dimensions of the change, a current picture of the area, what the completed change will look like, and the detailed materials of which it will be made, including colors, style etc. and all other requested documentation.

4th of July Fun!

Fireworks are commonly used to celebrate independence day.

There are several local fireworks shows throughout the county to enjoy. If you choose to celebrate at home, please remember, only fireworks that stay on the ground, like pinwheels, fountains and sparklers are legal to possess and use on private property in the state of Virginia.

- Keep a bucket of water and/or a hose nearby.
- Light fireworks on the ground and not in your hand.
- Never pick up 'duds' or fireworks that did not fire as they may still be active. Wait 20 minutes and treat as spent fireworks placing them in a metal container of water to cool overnight.
- Even sparklers need supervision as they burn about 2,000 degrees Fahrenheit which is hot enough to burn some metals.
- Some pets find is stressful when fireworks are nearby. You may want to consider keeping pets indoors, close curtains and turn on the TV or radio to distract them.
- Always follow manufacturer guidelines for use.
