- Please remember to attach all appropriate documentation and information required to process the application. An incomplete application will not be processed and will be returned to you.
- Homeowners should read the Association's governing documents before submitting this application

I understand that I am responsible for obtaining a Town of Warrenton building permit(s) as required, for certain projects such as decks, room additions, fences, etc.

I understand that members of the Architectural Review Board are permitted to enter upon my property at any reasonable time for the purpose of inspecting the proposed project, the project in progress, and the completed project, and that such entry does not constitute a trespass.

I understand that the Architectural Review Board's decision is required on all applications within 20 days of their receipt of the completed application.

I understand that the project must be started within 180 days of the approval date of the application and must be completed by the completion date indicated on the application or the approval becomes invalid.

If this application is for the installation of a deck or a fence, please check one of the boxes below:

- **For the installation of a deck** I understand that the deck may be allowed to weather naturally, or a clear or semi-transparent wood tone preservative may be used.
- □ For the installation of a fence I understand that vinyl fencing in a white color is the only material from which fences can be constructed. Two, three, or four rail, picket, and 5 foot privacy panels with 1 foot of lattice on top (total of 6 feet) are the only styles of fencing permitted.

I understand and agree that no construction or exterior alterations shall commence until written approval of the Architectural Review Board has been received by me. If any changes or additions are made prior to approval, or if the application is disapproved, I may be required to return the property to its former condition at my own expense, and may be required to pay all legal expenses incurred.
