You may have recently received a compliance inspection notice noting that your mailbox is out of compliance. A lot of mailboxes have missing numbers. This not only makes it difficult to have your mail delivered but can cost those extra important seconds that emergency personnel need to promptly respond to a call for help.

The developer of the Reserve at Moorhead installed Imperial Mailbox Systems throughout the community. In order to preserve the harmonious relationship among structures, the same mailboxes are to be maintained at each property. If you should need to order a complete replacement, it is style 888K.

To order individual items:

The box, post and number plate are all style 8.

The S Scroll is used under the box.

The numbers are the 2" brass numerals.

The Reserve at Moorhead's Declaration of Protective Covenants Article VI, Section 4 addresses activity that shall not be carried out on a property which may become an annoyance or nuisance to the neighborhood or may interfere with the quiet enjoyment of other owners at their home. Dogs bark. It is

When they are left unattended and allowed to bark for extended periods of time is when this can problem. become а The Town of Warrenton, VA code of ordinances, Section 11-19 states that the creation and continuation of any loud, disturbing and unnecessary noises in the town is hereby prohibited. In Section c(3) pets are specifically mentioned. The keeping of any animal which, by causing frequent or long continued noise, shall disturb the comfort or

repose of any persons in the vicinity. If found to be in violation of this ordinance can be found guilty of a Class 4 misdemeanor. As a dog owner, there are many ways to address this issue, from not leaving your pet outside for extended periods to training techniques.

Talking Trash

All rubbish, trash and garbage shall be regularly removed from the Property, and shall not be allowed to accumulate thereon. Trash must be stored in trashcans or tightly secured loose plastic bags. The trash containers must be stored out of the public view except when at the curb on trash collection days: Tuesday and Friday. Service may start as early as 7:00am on these days. Empty cans and any items not picked-up by the trash company must be removed from the curb following collection on the day of service.

The Town provides each residence with one box of 100 trash bags every year at no cost and may be picked up between 9am-5pm at the Warrenton Visitor Center, 33 North Calhoun Street.
