- To assist the Town's snow removal crews, try to minimize parking vehicles, on the street when snow is predicted. This allows plows to clear streets more completely, and thus reduces the risk of damage to your car from cars sliding on icy roads. - Remember to obey the speed limit within the Community. Excessive speed while driving through the community puts residents at risk of harm. Parked vehicles may reduce visibility. There may be times and weather conditions when special care must be taken for safety and slower driving speeds observed.
