Town of Culpeper Winter Trash Pick Up

Holiday schedule changes or changes due to inclement weather are announced on the radio on WCVA AM 1490 or WJMA FM 103.1, in the local newspapers, or Culpeper Media Network, on the Town's website, and posted at the Municipal Building at 400 South Main St.

Holiday tree pick up from the Town will be on Monday December 30, 2019 and Monday January 6, 2020. Please put your tree at the curb next to your trash can for pickup on these dates. All items must be removed from the trees, as they will be made into mulch.



Snow Preparation



To assist the Town's snow removal crews, try to minimize parking vehicles on the street when snow is predicted. This allows plows to clear streets more completely, and this reduces the risk of damage to your car from cars sliding on icy roads.

The sidewalk in front of your Redwood Lakes home should be kept clear of snow and ice to allow for safe pedestrian access in the community.
