Landscaping Maintenance

- Mulching was completed on 3/30/2020 and 4/1/2020

Street Lights

- One street light was converted to an LED light on 3/3/2020
- Four additional street lights were converted to LED on 4/17/2020

• Powerwashing the border fencing and the privacy fencing was completed on the fences March 16th and 17th

Landscaping Changes

Please ensure that you submit an Architectural Approval Form to the AAC prior to making any changes to the exterior of your Villas home, including all proposed planting bed changes such as the removal or addition of new plants or shrubs to the existing landscaping. All plantings installed by the builder or by the Villas are the property of the Association and cannot be removed without prior approval of the AAC. New planting beds installed by the unit owner must first be approved by the AAC prior to any work being undertaken.


